The Free Credit Check Service is for Hong Kong registered company which is engaged in export business. Each company can apply for a total of 20 buyers for free only.
2. 本服務不適用於信保局保戶。保戶可透過現有保單享用免費買家信用限額調查。
This service is not applicable to ECIC policyholders. ECIC policyholders should use the Free Credit Check Facility (CCF) offered to them under their existing policies.
3. 請確保您提供簽訂合約的買家全名及正確名稱(買家應是負責履行銷售合約付款責任的一方，而非代理人或收貨人)。
It is very important that you provide the full and correct name and address of your contractual buyer (i.e. the one who has the contractual obligation to pay for the goods / services, but not the agent or the consignee).
